VascuLife EnGS (containing Endothelial Cell Growth Supplement) is a low serum medium optimized for the culture of Human Endothelial Cells including Human Umbilical Vein Endothelial Cells (HUVEC), Aortic Endothelial Cells (AoEC), Iliac Artery Endothelial Cells (HIAEC), Pulmonary Artery Endothelial Cells (HPAEC), and other large-vessel endothelial cells. VascuLife EnGS supports the growth of these cells in a low serum environment without human VEGF.

VascuLife Basal Medium contains no antimicrobials and no phenol red. Lifeline offers antimicrobials and phenol red; however, they are not required for eukaryotic cell proliferation.





In comparisons with other commercially available media, VascuLife shows superior proliferation at different seeding densities.
